### **Payments**

10% holding deposit due on booking confirmation  
Full amount to be paid thirty days prior to event  
Any agreed bar account limits to be prepaid on day of function

### **Cancellation Fees**

Within 30 days prior to event 100%  
30 days prior to event 50%  
60 days prior to event 40%  
90 days prior to event 30%  
Over 90 days 20%

Any amendments, additions or deletions to the food requirements must be agreed in writing at least seven working days prior to the event and are subject to product availability.

### **Beverages**

Any bar account limit must be prepaid on the day of the function.  
Any increases to the bar account limit must be authorised and paid in full prior to being available for guests use.

If a certain beverage package has been chosen to include 'all local beers', 'all imported beers', 'Point house wines' or the like on the bar account, please be advised that Point drinks menu may change from time to time and is subject to product availability.

Point Management will make all reasonable endeavours to supply the requested products at the stated prices; however Point Management cannot guarantee certain products or quantities, which may be subject to availability.

All other drinks supplied will be charged to the prepaid bar account limit at Point's standard price list.

Alternatively guests are invited to pay Point staff separately for any special drink requirements at the time of ordering.

Please note that additional charges may apply.

### **Live music, DJ's, karaoke and/or amplified voice restrictions**

No amplification of music or voice is permitted from speakers located on the outside of the premises.

The volume level of noise emanating from entertainment/music and/or related activities in the restaurant area must not exceed 78dB ©, fast response when measured approximately 3 metres from the source of such notice with any doors open.

The volume level of noise emanating from entertainment/music and/or related activities in the restaurant area must not exceed 83dB ©, fast response when measured approximately 3 metres from the source of such notice with any doors closed.

Therefore we are unable by law to allow liver performers, DJ's, Duke Boxes, Karaoke Machines or similar.

Point Management during and before the event will make available it's noise recording device to assist in setting and managing this noise monitoring requirement.

Point Management reserves the right to adjust the volume of amplified sound at it's absolute discretion.

### **No smoking permitted**

Under Queensland Law it is illegal to smoke in or around the restaurant, bar or liquor licensed areas.

A smoking area has been established for guests in the two outdoor seating areas located either side of the entrance to the Rocks Resort premises.

Unfortunately Queensland Government Liquor Licensing laws prevent the consumption of alcohol in those designated smoking areas.

**Property damage**

Any property damage or unreturned equipment will incur an additional replacement or repair fee which will be added to the account.

Any drink glasses damaged or broken by guests may be charged at the rate of \$5 per glass.

Any excessive cleaning, rubbish removal or decoration requirements will be charged at the applicable rate. Weekend cleaning rates are \$50 per 30 minutes.

**Venue**

Please note there is no venue fee, equipment fee or surcharges applied for large bookings.

Point is a licensed resort restaurant and bar, in accordance with the Queensland Government Liquor Licensing Laws.

Point Management are not permitted to erect signage stating the facility is closed for a private function or similar wording.

At all times Point is open for business Resort guests are able to make use of the restaurant & bar area & facilities for bookings, dining, takeaways and bar service, subject to availability.

**Public holiday surcharges**

Point Management reserves the right to charge a fifteen percent (15%) surcharge on public holidays to all food, beverages & service prices, at its absolute discretion.

**Safety**

Point Restaurant & Bar endeavour to promote a safe and relaxed environment for all of our patrons, guests and residents. To ensure this, and by law, we must refuse service of alcohol to underage, intoxicated and disorderly patrons at all times.
